### **STEP 2: Checklist for Puppy Nomination**

- Puppy nomination must be made by owner and/or breeder.
- Postmark on envelope is before puppy reaches five (5) months of age and before Futurity stake entries close.
- Nomination fee (\$25.00/45.00) is enclosed. If applicable, late fee (\$15) is enclosed.
- For multiple nominations, there is a separate nomination form for each puppy.
- Litter has been registered with the PWDCA Health & Litter database.
- The litter nomination has been confirmed by the Futurity/Maturity Stake Coordinator.

### **STEP 3**: Entry in the Futurity/Maturity stakes class at the Specialty (\$10.00).

PUPPY MUST BE NOMINATED NO LATER THAN ONE (1) DAY PRIOR TO PUPPY'S 5-MONTH BIRTHDATE, OR AT LEAST ONE WEEK BEFORE FUTURITY STAKE ENTRIES CLOSE, WHICHEVER OCCURS FIRST. POSTMARK ON ENVELOPE WILL DETERMINE DATE OF NOMINATION. FAXED NOMINATIONS WILL NOT BE ACCEPTED.\*\*\*

For an additional \$15 Late/Penalty Fee, the puppy nomination may be accepted no later than one day prior to the puppy's five month and 14 day birth date, but at least two weeks prior to close of entries for Futurity if the puppy is competing in Futurity. Postmark on the envelope will determine date of nomination. The \$15 late fee includes both Futurity & Maturity.
